**Dogs:** \$22.00/ day (\$15.00 per 2nd or 3rd pet in same run) all have indoor/outdoor runs

**Deluxe Suite:** \$30.00/ Day **Doggie Daycare:** \$15.00/ Day **Cats:** \$50.00/ Day

**This includes 3-4 potty breaks outside in exercise yard, meals, and bedding.**

1. Owner agrees to pay the rate for boarding in effect on the date pet is checked into the kennel. The pet does not leave the kennel until all charges are paid.

2. Owner further agrees to all costs for special services requested and all veterinary costs for the pet during the time it is in the care of the kennel.

3. If pet requires veterinary attention, and you or your representatives are not reachable to make decisions, the kennel and its sole discretion may engage a medical professional to administer the required attention. Please note a trip to the Emergency Vet clinic is a minimum of \$250.00 and treatment would be more.

4. Kennel shall exercise reasonable care for the pet delivered by the owner to kennel for boarding, training, or grooming. It is expressly agreed by owner and kennel that kennel's liability shall in no event exceed the lesser of the current chattel value of a pet of the same species or the sum of \$200.00 per animal. The owner agrees to be solely responsible for any and all acts or behavior of said pet while it is in the care of the kennel. This includes harm to employees, property, and other guests.

5. All charges incurred by owner shall be payable upon pickup of pet. The kennel shall have, and is hereby granted, a lien on the pet for any and all unpaid charges. The kennel may exercise its lien right upon 10 days written notice to owner by certified mail to address on the permanent record. Kennel may dispose of pet, for any and all unpaid charges, at private or public sale or any other method kennel deems appropriate, in the sole discretion of the kennel, and owner specifically waives all statutory or legal rights to the contrary. If such sale shall not secure a price adequate to pay charges, then owner shall be liable for difference.

6. Owner understands that kennel cannot be held responsible for dirty, damaged, or destroyed belongings.

7. Owner specifically represents to kennel that the pet has not been exposed to rabies, parvo, distemper, or kennel cough within 30 days prior to said services, furthermore said pet has received an annual rabies, distemper, parvo, and canine cough vaccination which can be confirmed by the veterinarian listed on the permanent computer or original boarding record.

NOTICE: Any pet arriving with fleas or ticks must be treated/ bathed at owner's expense prior to boarding visits. In addition the kennel reserves the right to refuse services at any time for any reason regardless of reservations or prior arrangements. Revised 10/20/17 - effective immediately.

The signing of this contract denotes blanket consent for any and all times our boarding, grooming, or training services are provided.
